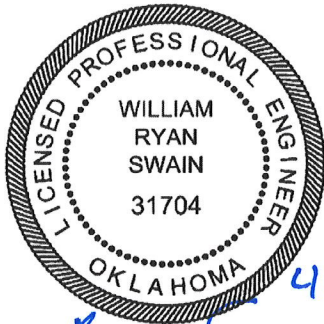

NOTICE TO BIDDERS

Notice is given that the Midwest City Municipal Authority (Authority) will receive sealed bids in the office of the Secretary, Midwest City Municipal Complex, 100 N. Midwest Boulevard, Midwest City, Oklahoma, until 2:00 p.m., on **May 1, 2025**, for:

TRENCHLESS STORM PIPE RESTORATION PROJECT

Any bids received more than ninety-six (96) hours, excluding Saturdays, Sundays, and holidays, before the time set for opening of bids, as well as bids received after 2:00 p.m. on the above date will be returned unopened. Bids shall be made in accordance with the bid documents, all of which are on file and available for public examination in the office of the Secretary in the Midwest City Municipal Complex. Complete sets of bid documents may be online via the city website: <https://www.midwestcityok.org/rfps>.

Bids filed with the Secretary shall be opened publicly and read aloud in the City Council Chambers at the time stated above or later. All bids shall be considered by the Chairman and Trustees of the Municipal Authority prior to the contract being awarded. The Authority shall consider awarding the bid at or after 6:00 pm on **May 27, 2025**, to the lowest and best bidder meeting specifications. The Authority may lay the same over to a subsequent meeting for comparison and computation.

The bidder shall use the City of Midwest City bid documents only and all forms must be signed and notarized/attested. The bidder shall file his/her bid in a sealed envelope. Each envelope shall bear a legible notation thereon that it is a bid upon the item proposed. The bid shall be filed with the Secretary in the City Clerk's office. All bids shall be typewritten or in ink.

ALL RESTORATION SHALL BE PERFORMED IN ACCORDANCE WITH THE CURRENT STANDARDS AND SPECIFICATIONS OF THE CITY OF MIDWEST CITY.
