

2024-03 **RESOLUTION OF PROJECT SPONSORSHIP
FOR A
TRANSPORTATION ALTERNATIVES PROGRAM APPLICATION
AND
MAINTENANCE AGREEMENT**

A RESOLUTION DECLARING THE ELIGIBILITY OF THE CITY OF MIDWEST CITY TO SUBMIT AN APPLICATION TO THE OKLAHOMA DEPARTMENT OF TRANSPORTATION FOR USE OF TRANSPORTATION ALTERNATIVES PROGRAM FUNDS SET FORTH BY IJA FOR THE CRUTCHO CREEK TRAIL PHASE 1 PROJECT IN MIDWEST CITY AND AUTHORIZING THE CITY MANAGER TO SIGN THIS APPLICATION

WHEREAS, the City of Midwest City, Oklahoma, is submitting an application to the Oklahoma Department of Transportation for transportation alternatives program funds in the amount of \$960,000, set forth by IJA and as outlined in ODOT's transportation alternatives program guidance & application packet for 2024; and

WHEREAS, the City of Midwest City, Oklahoma, is participating as an eligible project sponsor in the Oklahoma Department of Transportation's transportation alternatives program set forth by IJA; and

WHEREAS, federal monies are available under a transportation alternatives program set forth by IJA, administered by the state of Oklahoma, Department of Transportation, for the purpose of creating and promoting the planning and development of active transportation facilities and programs in Oklahoma; and

WHEREAS, the City of Midwest City, Oklahoma, acknowledges availability of the required local match of no less than 20%; and

WHEREAS, after appropriate public input and due consideration, the governing body of Midwest City, Oklahoma, has recommended that an application be submitted to the state of Oklahoma for the Crutcho Creek Trail Phase 1 project.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF
MIDWEST CITY, OKLAHOMA**

SECTION 1. That the City of Midwest City, Oklahoma, does hereby authorize the City Manager to submit an application to the Oklahoma Department of Transportation for transportation alternatives program funds set forth by IJA on behalf of the citizens of Midwest City, Oklahoma.

SECTION 2. That the City of Midwest City, Oklahoma, hereby assures the Oklahoma Department of Transportation that sufficient funding for the Crutcho Creek Trail Phase 1 project is available.

SECTION 3. That the City of Midwest City, Oklahoma, hereby assures the Oklahoma Department of Transportation that sufficient funding for the operation and maintenance of the Crutcho Creek Trail Phase 1 project will be available for the life of the project.

SECTION 4. That the City of Midwest City, Oklahoma, hereby assures the Oklahoma Department of Transportation that the City of Midwest City, Oklahoma will have title or permanent easement to the Crutcho Creek Trail Phase 1 project by the time of project letting, if necessary.

SECTION 5. That the chief project sponsor of Midwest City, Oklahoma is authorized to sign the application to the Oklahoma Department of Transportation for transportation alternatives program funds set forth by IJA on behalf of the citizens of Midwest City, Oklahoma. The chief project sponsor is also authorized to submit additional information as may be required and act as the official representative of the City of Midwest City in this and subsequent related activities.
