MEMORANDUM

Subject: Discussion, consideration and possible action to accept or reject all bids received for Project 952501: Monuments Signs for the Soldier Creek Industrial Park. (Economic Development – R. Coleman)

American Glass, Inc. and AGI Properties on August 22, 2023, (the “Companies”) entered into the Amended and Restated Economic Development Agreement (the “Agreement”) with the Utilities Authority and the Economic Development Authority (the “Authorities”). In Section 4.04 of the Agreement, the Authorities committed to fabricating and installing at least one subdivision sign at one of the two entrances to the Soldier Creek Industrial Park (“SCIP”). The FY 2024 – 2025 Budget included \$70,000 for this endeavor, which became known as Project 952501. ROAM Studios, the architectural firm that won the award for the American Glass, Inc. campus and building design, was paid \$10,000 to create plans for the sign(s).

Unfortunately, we received only two (2) bids before the June 18, 2024, deadline, the lowest of which was more than *double* the amount that remained available for the work.

As part of the Agreement, the Authorities also committed to designing and constructing a switch and industry track to serve SCIP at an estimated cost of \$2 million (in 2023 dollars). We pursued and were awarded a U.S Federal Railroad Administration Community Railroad Infrastructure Improvement grant that promised to reimburse up to 75% of the rail project’s design and construction costs.

We chose to delay additional action on Project 952501 until we were more confident in the U.S. FRA’s commitment. Due to US FRA requirements, it has taken nearly two (2) years to acquire permission to move forward with the rail project, but we now hope to bid the job and start work within the next six to eight weeks.

The Companies are interested in seeing Project 952501 completed as quickly as possible, and they are willing to contribute their collective resources to see that both signs are built and installed as designed. This cooperation will likely be memorialized in an amendment to the original Agreement, which is expected to occur on next month’s agendas.

- For anything requiring shop drawings, only 1 revision is included in the bid. Every revision after that will be billed at an additional rate of \$75/hr
- does not include ELES or "Electric Sign Permit" must be pulled by licensed electrician
- All ground signs require vegetation in the OKC area. G&S Signs is not responsible for the installation of vegetation unless specified in quote.
- G&S Will Call OKIE to foresee any drilling implications. Unknown underground obstructions, rock, or hard sediment not included in bid. It is the responsibility of the land owner to mark all private lines including water sprinklers.
- With the removal of an existing wall sign, quote includes caulking holes to prevent water damage. Patch and spot paint, EIFS restoration and painting seam to seam will be quoted separately unless specified in quote.
- For all ship in work. Standard procedure is to check crates and packages when they come in. If they have no visible exterior damage they are marked OK. We will only investigate crates/boxes further if they have exterior damage. Internal damage will not be G&S's responsibility to cover costs.

ELECTRICAL NOTES:

Due to lack of information we have quoted this based on these items :

Sign is no more than 2 circuits @ 15 amps ea and voltage is 120v/240v

NOTE* price can possibly be reduced if loads are lesser than quoted or significantly increase based on actual voltage and loads.

Option #1 – To build new service at each sign location no more than 25ft from each sign and connect as required by code. This would require the power company to bring power to each location, this would have to be coordinated with them but must know voltage and amperage before.

Option # 2 – To build solar boxes at each sign location. Once again this is based on 2 – 15a circuits running for 10 hours continually.

Option # 3 – Would have to verify first but it is a possibility based on actual load and voltage. Could possibly pull new circuits through existing pole light conduits and feed signs that way. No price for this but if power companies do not want to build two new services it is a viable alternative.

STEEL NOTES:

Qty (1) Soldier Creek Monument Sign comprised of materials shown on pg A10.0A dated Sept 20, 2024. Expanded metal priced as 1/2 x 13 flat. HSS3x3x3/8 tube frame and lateral L6x3 1/2x5/16 to be primed and painted by Walliefab at the shop. Exterior 1/4" HR plate placards to be powder coated black. Expanded metal to be powder coated black. Note that any welds on powdercoated material will need touch up painted on site. Some suggestions to avoid this where applicable may be presented in the shop drawing process. Price dependent on a single standard powder coat color. 3/4" frosted acrylic backing included. (1) telehandler lift rental included in price. Joints on back face where expanded metal meets will need horizontal support for attachment and to add rigidity to panels.
