Subject: Discussion, consideration, and possible action to approve a Resolution of the Midwest City Economic Development Authority and the Midwest City Utilities Authority amending that certain Amended and Restated Economic Development Assistance Agreement, Dated August 22, 2023, (the “Agreement”) by and between the Authority and American Glass, Inc. and AGI Properties LLC; authorizing and directing the execution and delivery of the First Amendment to the Agreement; and containing other provisions relating thereto. (Economic Development – R. Coleman)

---

American Glass, Inc. and AGI Properties on August 22, 2023, (collectively the “Companies”) entered into the Amended and Restated Economic Development Agreement (the “Agreement”) with the Utilities Authority and the Economic Development Authority (the “Authorities”). In Section 4.04 of the Agreement, the Authorities committed to fabricating and installing at least one subdivision sign at one of the two entrances to the Soldier Creek Industrial Park (“SCIP”). The FY 2024 – 2025 Budget included \$70,000 for this endeavor, which became known as Project 95201. ROAM Studios, Oklahoma City, was paid \$10,000 to create plans for the signs.

Unfortunately, we received only two (2) bids before the June 18, 2024, deadline, the lowest of which was more than *double* the amount that remained available for the work. The Authority rejected both bids during its January 27, 2026, meeting.

In Section 4.02 of the Agreement, the EDA agreed to reimburse the Companies up \$50,000 for any expenses incurred in extending any public utility, or for other improvements within public easements or rights-of-way. This benefit went unclaimed, and those funds are now being recommended for use to complete Project 95201.

The Companies desire to see this project finished as quickly as possible and are willing to contribute their collective resources so that both signs are built and installed as designed. This cooperation is memorialized in the attached First Amendment, which requires the Companies to do all tasks necessary to install signs in permanent easements on AGI Properties’ land at the SE corner of American Drive and U.S. Highway 62 (a/k/a NE 23<sup>rd</sup> ST) and at the SW corner of U.S. Highway 62 and Soldier Street.

In return, the EDA will reimburse American Glass up to \$110,000 for materials, labor and other expenses incurred to complete Project 95201 and the Utilities Authority will assume responsibility for illuminating and maintaining the signs and surrounding easements.

**A RESOLUTION OF THE MIDEST CITY ECONOMIC DEVELOPMENT AUTHORITY AND THE MIDWEST CITY UTILITIES AUTHORITY AMENDING THAT CERTAIN AMENDED AND RESTATED ECONOMIC DEVELOPMENT ASSISTANCE AGREEMENT, (the “AGREEMENT”) DATED AUGUST 22, 2023, BY AND BETWEEN THE AUTHORITIES AND AMERICAN GLASS, INCORPORATED AND AGI PROPERTIES LLC; AUTHORIZING AND DIRECTING EXECUTION AND DELIVERY OF THE FIRST AMENDMENT TO THE AGREEMENT; AND CONTAINING OTHER PROVISIONS RELATING THERETO.**

**WHEREAS**, AGI Properties, an Oklahoma limited liability company (hereinafter “AGI”), developed the northern ± 11.7-acres Soldier Creek Industrial (“SCIP”) Park leading to the December 17, 2024, issuance of a Certificate of Occupancy for a 106,000 ft.<sup>2</sup> first-class, attractive building on a well adorned campus at 2150 American AV (the “Property”), which is a shining example of new construction in the U.S. Highway 62 corridor and an impressive addition at the western gateway to Midwest City; and

**WHEREAS**, American Glass, Incorporated, an Oklahoma corporation (hereinafter “American”), operates a factory and headquarters on the Property that builds glass curtain wall panels to serve the building industry across the United States and beyond; and

**WHEREAS**, AGI and American (the “Companies”) agree to assist the Utilities Authority and the Economic Development Authority (the “Authorities”) to complete Project 95201 in a timely fashion, thereby working together to enhance the U.S. Highway 62 corridor and to help ensure SCIP’s future success; and

**WHEREAS**, the Companies agree to work jointly to obtain the necessary easements, licenses, permits and inspections; and to obtain all materials and labor necessary for the fabrication and installation of illuminated subdivision signs as described in designs ROAM Studio produced for Project 95201 and as described in this First Amendment to that certain Amended and Restated Economic Development Agreement, dated August 22, 2023 (the “Agreement”); and

**WHEREAS**, the Companies and the Authorities are hereby amending the Agreement to the benefit of all parties; and

**WHEREAS**, the Authorities’ Trustees have determined that it is in the best interest of the residents of Midwest City, Oklahoma, that this First Amendment be approved.

**NOW, THEREFORE, BE IT RESOLVED BY THE CHAIRMAN AND TRUSTEES OF THE MIDWEST CITY ECONOMIC DEVELOPMENT AUTHORITY AND THE MIDWEST CITY UTILITIES AUTHORITY, AS FOLLOWS:**

**SECTION 1. Approving the Terms and Conditions of the First Amendment.** The Trustees of the Authorities hereby approve the First Amendment, by and between the Authorities and the Companies, in substantially the form submitted at this meeting, with such changes as made be hereafter approved by the Chairman of both Trusts.

**SECTION 2. Authorizing and Directing Execution and Delivery of the Amended Agreement and All Related Instruments.** The Chairman and the Secretary are hereby authorized and directed to execute and deliver the First Amendment and such other instruments as may be necessary or appropriate to effectuate the execution and delivery of the First Amendment.

## AMERICAN GLASS PROJECT

### **FIRST AMENDEDMENT TO THE RESTATED AND AMENDED ECONOMIC DEVELOPMENT ASSISTANCE AGREEMENT**

THIS FIRST AMENDED RESTATED AND AMENDED ECONOMIC DEVELOPMENT ASSISTANCE AGREEMENT, dated as of February 24, 2026, (hereinafter, the “Development Assistance Agreement”), is made and entered into by and among the Midwest City Economic Development Authority (hereinafter “EDA”), an Oklahoma public trust; the Midwest City Utilities Authority, an Oklahoma public trust, (hereinafter, the “Utilities Authority”), AGI Properties, LLC, an Oklahoma limited liability company (“AGI”), and American Glass, Inc., an Oklahoma corporation or its assigns, (hereinafter, the “Company”).

The following provisions of the Restated and Amended Economic Development Assistance Agreement are hereby amended as follows:

**SECTION 4.02** The EDA and the Utilities Authority agree to work with AGI and the Company to facilitate the fabrication, assembly, placement and installation of two (2) Subdivision Signs (the “Signs”) designed by ROAM Studios for EDA Project 95201 and are attached to this Amended Agreement as Appendix 2, with each party agreeing to complete their respective responsibilities as follows:

- (i) The Company’s responsibilities:
  - a. Obtain proper easements from AGI Properties LLC as follows:
    - i. Permanent sign easements in favor of the City of Midwest City and the Midwest City Utilities Authority extending at least six (6) feet in any direction from the widest point of the Signs, except areas that lie in existing public rights-of-way, as shown on A10.0 of Appendix 2; and filing said easements with the Oklahoma County Clerk’s Office.
    - ii. Any additional easement(s) in favor of the City of Midwest City and the Utilities Authority necessary to provide (a) legal path(s) to extend permanent electrical power to the Signs.
  - b. Obtain all materials specified in the ROAM Studios design and shown as A10.0A of Appendix 2. Any exceptions to these materials must be approved in advance by the Midwest City Utilities Authority General Manager/Administrator as recommended by Matt Weber, AIA, ROAM Studios.
  - c. Employ the services of a sign contractor licensed by the City of Midwest City (“City”) to complete the following requirements:
    - i. Obtain a separate City permit for each Sign.
    - ii. Contract with an electrician licensed by the City to obtain permits to extend power to each Sign; and to request inspections as required by Construction Services.
    - iii. Assemble and install all materials in accordance with the recommendations and designs from ROAM Studios as shown as A10.A of Appendix 2 and as per current City codes.
  - d. Assist as necessary in transferring responsibility for the electric bill from OG+E to the Utility Authority following the approval of all inspections required by the City.
  - e. Within three (3) weeks of the City’s final approvals and the closing of all permits, the Company shall submit an invoice on a Company letterhead requesting payment. Said invoice must detail all costs and expenses incurred the successful completion of Project 95201 with copies attached of each contractor’s or supplier’s invoice referenced by the Company invoice indicating the source, quantity and price of each item.

- (ii) The EDA's Responsibilities. Within thirty (30) days of receiving proper documentation outlined in §4.02(i)e above, the EDA agrees to reimburse the Company a total not to exceed \$110,000 for materials, labor and professional services necessary for the successful completion of Project 95201.
- (iii) The Utility Authority's Responsibilities. The Utility Authority's responsibilities shall survive the termination of this Development Assistance Agreement but may be transferred to another City of Midwest City entity. These responsibilities include:
  - i. Establishing and enforcing a policy for the design, size, installation and maintenance of individual sign panels.
  - ii. Maintaining the Signs' structure, electrical wiring, lighting, panels and landscaping improvements within the easements described in § 4.02(i)a hereinabove.
  - iii. Paying the cost of electric service for each Sign.

**SECTION 7.02 Notices.** Any notices or other communications required or permitted hereunder shall be sufficiently given if delivered personally or sent by - certified mail, postage prepaid, return receipt requested or a delivery service requiring a signature upon delivery and addressed as set forth below or to such other address as the party concerned may substitute by written notice to the other. All notices shall be deemed received on the date signed for by recipient.


